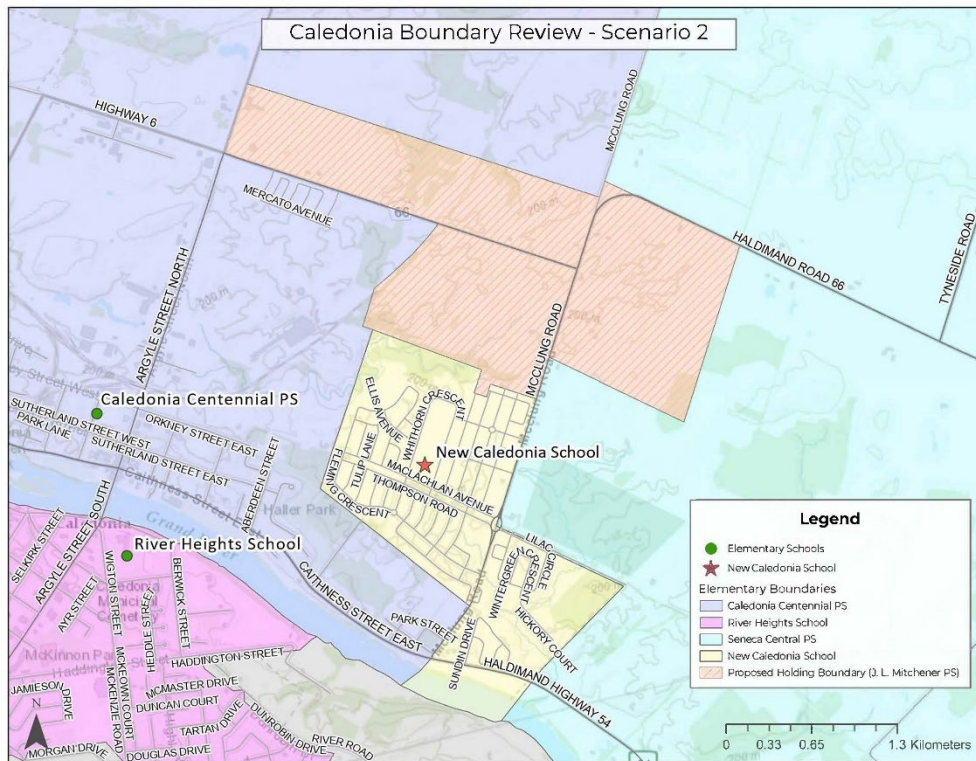
Boundary Review Working Committee: Public Meeting Feedback Review
