


Fig. 1 – Proposed boundaries: Caledonia Boundary Review

THAT the amended school boundaries for Caledonia Centennial Public School, Seneca Central Public School, J.L. Mitchener Public School, and the new school boundary for the new Caledonia school, as outlined in Figure 1, effective September 1, 2025 be forwarded to the January 27, 2025 Regular Board meeting for approval.

### Background

Grand Erie District School Board (Grand Erie) received Ministry of Education approval and funding for a new 441 pupil place joint elementary school and childcare facility as part of the 2021 Capital Priorities Program (CPP). Construction of the new school is underway and on schedule to open September 2025.

The new school is located within the existing boundary of Caledonia Centennial Public School in what is known as the Avalon development. Effective September 26, 2023, Caledonia Centennial Public School reached full capacity and new students registering within the boundary were directed to J.L. Mitchener Public School, which would act as a holding school until the new Caledonia elementary school was complete.

On June 24, 2024 Grand Erie's Board of Trustees approved the commencement of a Boundary Review to establish a school boundary for the new Caledonia elementary school. This review would also include Caledonia Centennial Public School, River Heights Public School, Seneca Central Public School, and J.L. Mitchener Public School.

It is important to note that further residential development is anticipated for the Town of Caledonia. Grand Erie's Long Term Accommodation Plan (LTAP) has identified the need for an additional elementary school within the Town of Caledonia and Grand Erie staff have been collaborating with Haldimand County in identifying an additional school site in future plans of a subdivision. J.L. Mitchener Public School will continue to act as a holding school for future residential development within the Town of Caledonia (See Figure 1) in advance of the next new elementary school.

#### Process

Following the approval of this boundary review, and in accordance with the steps outlined in Boundary Reviews Policy (FA-08), a Boundary Review Working Committee was struck. The Committee met between September 2024 and November 2024 to review options and gather community feedback during public meetings. ### Additional Information

As of September 2025, the new Caledonia elementary school will offer Grades K-8 for the area described in **Figure 1.** 

This new elementary boundary includes the existing Avalon development as well as portions of the current Seneca Central Public School boundary. As a result of the new boundary, students would be transferred from Caledonia Centennial Public School, Seneca Central Public School, and J.L. Mitchener Public School to the new Caledonia elementary school. To ease the transition for students and families, a legacy option is proposed for 2025-26 Grade 8 students within the new boundary. These students would have the option of remaining at their current school for the 2025-26 school year or attend the new Caledonia elementary school. Students choosing the legacy option would be provided transportation should they meet the transportation eligibility criteria.

Feedback received at the committee and public meetings has been positive. The committee, along with community support, are fully dedicated to facilitating smooth transitions and providing robust support structures within the schools.

The proposed boundaries would see a significant reduction in the number of transported students and related costs. Approximately 375 previously transported students would be within walking distance to the new Caledonia elementary school.

Temporary accommodation needs (portables) would also be reduced. It is anticipated that all of the current portables at Caledonia Centennial and Seneca Central Public Schools (7 and 3 respectively) would no longer be needed based on projected school capacity utilization (**See Table 1**).

### Recommendation

Pursuant to the steps outlined in Boundary Reviews Policy (FA-08), and based on committee consultation, Senior Administration recommends establishing the amended school boundaries for Caledonia Centennial Public School, Seneca Central Public School, J.L. Mitchener Public School, and the new Caledonia elementary school.

THAT the Grand Erie District School Board refer the proposed École Dufferin and École Confederation French Immersion Boundary Review to a working group for stakeholder feedback and input.

### Background

Currently, École Dufferin and École Confederation provide French Immersion programming in a single-track model for students in kindergarten to Grade 8. All elementary students in the City of Brantford that access French Immersion programming in Grand Erie attend one of these two schools.

### Additional Information

École Dufferin and École Confederation are currently at 83% and 77% capacity utilization, respectively. Based on the current boundaries, there is increasing enrolment pressures at École Dufferin upon initial registration into French Immersion programming in Kindergarten or Grade 1.

Based on enrolment pressures, the Boundary Review process will be compressed to ensure that the new boundaries are in place for September 2025.

#### Next Steps

Pursuant to the steps outlined in Boundary Reviews Policy (FA-08) and Procedure (FA-008) Boundary Reviews, Senior Administration, with Board approval, will form a working group which will be tasked with the coordination of a public meeting. The goal is to have a recommendation to the Board by March 2025 Regular Board meeting.




Figure 1 – Current (2024-25) École Dufferin/École Confederation boundaries
